TERMS & CONDITIONS

1. Under this scheme minimum principal deposit is Tk. 1,00,000 (Taka one lac). The client can deposit any amount in multiples of Tk. 50,000 (Taka fifty thousand) subject to a maximum amount of Tk. 1,00,00,000 (Taka one crore) either singly or jointly.
2. The tenure of Special Deposit Scheme (SDS) is 1 (one) / 2 (two) / 3 (three) years.
3. If the account is encashed or closed before maturity, following rules will be applicable to settle the account: (I) Less than 12 months - no interest/profit (II) 12 months to 36 months - interest/profit at savings rate. If the interest/profit amount already paid is more than the interest/profit amount payable, the Bank reserves the right to adjust the excess amount from the principal deposit.
4. In case of death of the Depositor the relevant account will be closed. Nominee shall receive the amount of deposits.
5. Depositor has to pay income tax, excise duty etc. as per government/regulatory rules.
6. A receipt will be provided to the Depositor which is non-transferable.
7. If there is any loan in the name of the Depositor(s) with Dhaka bank Limited (DBL), then DBL shall have the right to adjust the loan amount from the deposit which has been deposited by the Accountholder for Depositor under SDS.
8. The principal deposit cannot be submitted or marked lien to avail any loan from any financial institution except DBL.
9. Clients will have the option of availing overdraft limit upto 90% of total investment.
