- 2. Any Government Taxes, Duties or other charges will be recovered in addition to the foregoing and as per Government Regulations.
- 3. Stamp charges are levied where applicable.
- 4. Correspondents /Other Bank charges, if any, will be additionally recovered from customers.
- 5. The Bank reserves the right to assess charges on transactions which are not covered by this schedule and to amend without prior notice the terms or conditions stated in this schedule.
- 6. Any service, which is not mentioned in the Schedule of charges, will be charged separately.
